The final package will be ready within 2 months after the order is placed and all payments are made.

All images remain the sole ownership and copyright of Mike Nyman Photography, but Client has the right to make prints and digital copies for personal use only. Personal use includes making prints or digital copies for family and friends. Mike Nyman Photography may use images of the wedding couple for self-promotion online and in print.

Liability limitation notice: Client agrees to accept a refund proportional to the number of photos taken during the wedding day (up to the total package cost in the unlikely event that all photographic materials are lost, damaged, or destroyed, or an accident or extreme emergency prevents photographer from fulfilling agreed services), as your exclusive remedy, and as the limit of photographer's liability should any of the photographic materials be lost, damaged, or destroyed, regardless of client's damages, including incidental and consequential, regardless of client's legal theory, including negligence and strict liability.
